### 2.1 Emergency Overview

### 5.1 General Hazards:

Product is not considered flammable or combustible. Products of combustion include compounds of phosphorus, toxic oxides of phosphorus and spontaneously flammable phosphine gas.

### 5.2 Extinguishing Media:

Carbon dioxide, water, water fog, dry chemical, chemical foam.

### 5.3 Fire Fighting Procedure:

Decomposes violently when 100% sodium hypophosphite is heated above 200°C (392°F) and will yield toxic oxides of phosphorus and phosphine gas. Under these conditions, DO NOT extinguish flames due to the possibility of phosphine gas accumulation. Use water spray to cool containers.

#### **5.4 Unusual Fire / Explosion Hazards:**

Phosphine gas liberated during overheating of 100% sodium hypophosphite is extremely flammable and toxic. It reacts violently with oxygen and halogens.

#### **5.5 Hazardous Combustion Products:**

Smoke, fumes or vapors, toxic oxides of phosphorus and spontaneously flammable phosphine gas.

#### **6.1 STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED:**

Small spills - wash to sanitary sewer with plenty of water. Large spills - Recover and segregate product for reuse; shovel product into approved container for disposal.
